CANINE LEGISLATION REPORT

• Second session is almost over,(ending on the 28th of April) and any bills that have not made it through the second committees by the time this is read, will be done and waiting to try again next year. With 11 bills concerning dogs this year, it is amazing that 4 look like they are going to make it all the way through! These four have made it through both House and Senate committees and are waiting for legislature approval, then off to the desk of our Governor to be signed into bills, or bill amendments!

• First I want to comment on last month's AKC Government Relations article in the Northwest Shepherd News. This was concerning HB 1640 which would have prohibited retail pet stores from selling any dog or cat, unless it had been obtained from rescue and or Human societies. Along with several other issues in the bill. No need to worry this year, as this never made it out of the first session, BUT be aware of it, as it will most likely come back next year to try again!

. These are the bills that look like they will make it to new laws, and or law amendments;

. **HB 1476** - Concerns contracts for the sales of dogs and cats. The wording has been changed and some amendments made, making this bill a lot more acceptable, AND more defined in the difference between a regular sales contract, which will be legal, and contracts that will be made illegal, such as any leases, or contracts that name the animal as collateral.

. **Summary:** A live dog or cat may not be named as collateral for a consumer lease or secured transaction, If a consumer enters into a contract that grants a security interest in the live dog or cat, the consumer is deemed to be the owner of the live dog or cat and is entitled to the **RETURN OF ALL AMOUNTS** the consumer paid under the contract, in addition to any other remedy provided by law, The bill does not apply to contracts for

payments to repay an unsecured loan for the purchase of a dog or cat.

. **SSB 5004**-An act relating to allowing animal care and control agencies and non-profit humane societies to provide additional veterinary services to low-income households.

. **Summary:** Allows veterinarians and veterinary technicians employed by animal control agencies and non-profit humane societies to provide veterinarian services to animals owned by low-income households, providing limited veterinarian services, including sterilization, vaccination, and electronic identification (low-income household means a household whose income is less than 80% of the median family income, adjusted for household size, for the county where the household is located). Limited emergency care, to save a life or keep an animal from severe disabilities, is also covered in this bill.

. **SSB 5212** - An Act relating to adoption of dogs and cats for science or research purposes; adding to a new section and creating a new section

. **Summary:** The new section breaks down exactly what is required and not required by the research facilities when it comes time to possibly adopt dogs and cats that are no longer needed or being used by such research facilities. ALSO a new section that will make this act known and sited as the "Homes for Animal Heroes Act"

. **HB 1919** - Discussed in the last issue of NW Shepherd News, this bill expands the circumstances in which a person may commit an animal fighting offense, to include (1) stealing an animal for fighting, (2) Possessing, transferring, manufacturing, or engaging in other activities relating to animal fighting paraphernalia. Also the bill elevates the classification of Animal Fighting from a class C felony to a class B felony when a person intentionally mutilates an animal in furtherance of the offense. HB 1919 also provides that a person is guilty of animal cruelty in the second degree when he or she abandons an animal



that has been used for fighting and thereby causes or risks harm to the animal.

So, these are the four that have made it through both sessions and should have no trouble finishing out and getting passed into law! By next month's issue we will know for certain what has made it to new law, and/or amendments to current laws! Just because a bill has cleared both houses

does not necessarily mean the legislature is going to pass it off to the governor to sign, AND does not guarantee that the governor is going to sign it!

Check back next month for the finals of the Wa. State legislative session, and see what changes might affect you and your dogs and/or cats!

AND REMEMBER YOUR VOTE DOES COUNT!



A dog food representative in Fred Meyer one week snagged me when she saw I was looking at dog food. We stood and talked quite a while (I was able to educate one more person in the world that Shepherd has an "h" in it. I had on a vest that had a German Shepherd on the back of it.

Anyway, she gave me the little flyer on the right about an event called Petpalooza being held at the Game Farm Park in Auburn. If you go, be sure to wear a club shirt or jacket to advertise our club – and teach a few more people how to spell Shepherd. You can enter the Dog Trot at 3K or 5K and I think she said there was going to be obedience rings and agility rings set up. Check out their web site for other events.

Phishing

Phishing is when a scammer uses fraudulent emails or texts, or copycat websites to get you to share valuable personal information - such as account numbers, Social Security numbers, or your login IDs and passwords. Scammers use your information to steal your money or your identity or both.

Scammers also use phishing emails to get access to your computer or network then they install programs like [ransomware](#) that can lock you out of important files on your computer.

Phishing scammers lure their targets into a false sense of security by spoofing the familiar, trusted logos of established, legitimate companies. Or they pretend to be a friend or family member.

Phishing scammers make it seem like they need your information or someone else's, quickly - or something bad will happen. They might say your account will be frozen, you'll fail to get a tax refund, your boss will get mad, even that a family member will be hurt or you could be arrested. They tell lies to get to you to give them information.

Be cautious about opening attachments or clicking on links in emails. Even your friend or family members' accounts could be hacked. Files and links can contain [malware](#) that can weaken your computer's security.

Do your own typing. If a company or organization you know sends you a link or phone number, don't click. Use your favorite search engine to look up the website or phone number yourself. Even though a link or phone number in an email may look like the real deal, scammers can hide the true destination.

Make the call if you're not sure. Do not respond to any emails that request personal or financial information. Phishers use pressure tactics and prey on fear. If you think a company, friend or family member really does need personal information from you, pick up the phone and call them yourself using the number on their website or in your address book, not the one in the email.

Turn on two-factor authentication. For accounts that support it, two-factor authentication requires

both your password and an additional piece of information to log in to your account. The second piece could be a code sent to your phone, or a random number generated by an app or a token. This protects your account even if your password is compromised.

As an extra precaution, you may want to choose more than one type of second authentication (e.g. a PIN) in case your primary method (such as a phone) is unavailable.

Back up your files to an external hard drive or cloud storage. Back up your files regularly to protect yourself against viruses or a ransomware attack.

Keep your security up to date. Use security software you trust, and make sure you set it to update automatically.

Report phishing emails and texts.

- Forward phishing emails to spam@uce.gov - and to the organization impersonated in the email. Your report is most effective when you include the full email header, but most email programs hide this information. To ensure the header is included, search the name of your email service with "full email header" into your favorite search engine.
- File a report with the Federal Trade Commission at [FTC.gov/complaint](https://www.ftc.gov/complaint).
- Visit [Identitytheft.gov](https://www.identitytheft.gov). Victims of phishing could become victims of identity theft; there are steps you can take to minimize your risk.
- You can also report phishing email to reportphishing@apwg.org. The Anti-Phishing Working Group - which includes ISPs, security vendors, financial institutions and law enforcement agencies - uses these reports to fight phishing.

(This is about a year old and was sent out by AKC, but I figured it is still applicable to our lives, maybe even more so.)
