AKC has, at the request of their parent club, added Alaskan Malamutes to the other breeds that also only have to jump  $\frac{3}{4}$  of their height in obedience. There are 41 breeds on that list...I was surprised to see so many. Gee, back in the days when I started, our dogs jumped  $1\frac{1}{2}$  times their height. We've all come down in the world, some more than others.

Well, our area was hit hard by the Corona Virus...and so were the stores. When I went shopping a few days later, the shelves were empty where the hand sanitizer was and also the shelves where they keep the eggs, bleach and toilet paper...I haven't figured that one out yet. We haven't had as many cases, but we have had the most deaths. As of now we have had 95 people (but no new ones yesterday) from this state that have died from the virus. On tv they said the big stores also ran out of paper towels and toilet paper.

Here is another example of "Accidental/Unconscious Training. "Bell on the Door". I learned this little trick quite a few years ago. Can't remember who told me, but it was a great "trick". You hang a bell on the door (in my case the door to the back yard) and every time your dog wants to go out, you tell him/her to "ring the bell". At the beginning they don't know what you are talking about of course, so gently push their nose against the bell, and when it rings you praise the dog and let him/her out. It doesn't really take very long for them to get the idea.

Even my old cat learned to ring the bell. (Shadow never goes out so no need for him to learn it.) He'd want out and I'd be busy working on my computer, so he'd ring the bell. If I ignored that, he would haul off and whop that bell as hard as he could; then I would let him out before he damaged something.

When your dog "really" has to go out, he'll learn pretty fast. Last year I had some private students in the front room and we're talking when I heard a faint tinkle from the kitchen. I jumped up and said, "Oh, wait a minute, I have to let my dog out." When they asked how I knew that, I asked them, "Didn't you hear the bell?" They were flabbergasted the dog knew to do that to go out. The dog learns it pretty fast when he has a reason to go outside, like going potty.

The only problem I've ever had with this is finding something tough enough to tie the bell with as after a while just yarn, thread, or rubber bands wear out and have to be replaced. A few years ago I bought a Christmas hanging with bells on it with a loop at the top and have used that ever since. It's beginning to show wear and tear, but still works perfectly. Or you can just use a bell or two tied together, a rattle, anything that makes noise.

If you have a small dog, be sure to hang the bell low enough so the dog can poke it with his nose without having to reach up. You don't want make it difficult for the dog. If Wrangler has a lapse of memory and just stand at the door or barks, I walk up to the door and hold my hand on it and tell him to "ring the bell" and don't open the door until he does. If you are really consistent about this, the dog won't test you (or hardly ever anyway — guess we all have a lapse of memory every once in a while).

Can we have a puzzle exchange at the meetings? I read somewhere that if you work on puzzles it will help slow down the onslaught of dementia. I had three small puzzles so I dug them out and did 2 of them with no problem (I didn't like the picture on the third one). I hate doing the same puzzle over and over, so if anyone would like to bring some

"small" puzzles to the meeting, I will trade you and then bring them back the following month. I say "small" because I don't have anywhere I could leave a large one up as I am sure I wouldn't be able to do it in one day. You can just see what would happen leaving a puzzle out...good chance Wrangler and Shadow would try to help put it together.

I belong to one of those "Neighborhood" lists and was very impressed on how quickly people were writing in and offering help in taking care of kids when the schools were closed. Others wrote in and offered to run errands or do yard work, picking up and delivering meals for those "older" citizens that are staying in since they are at high risk of catching "The Virus". We're all being inconvenienced by this "pandemic", but it is also bringing good out in many others, even commercial businesses jumping in to help make hand sanitizer to give out for free because the hoarders have bought up all that were for sale in the stores.

One of my former students was the first death in Pierce County. So sad...good student, good competitor, and all-around nice person.

We finally had several days in a row with no rain and decided it was time to do "the first cutting" of my long grass. Made one pass around the yard and then happened to look down and saw one of the front tires was so flat I couldn't blow it up. My son-in-law came over and took both of the front tires off. The next day I went down to Tractor Supply and bought two new ones and brought them home; my son-in-law put them on, and off I went. Had all the grass mowed before too many clouds came in. Now have to wait for another fairly nice day to do all the weed eating, that may take another week, then it will be time to mow again.

A friend from high school who lives on Maui lost her 11- $\frac{1}{2}$  year old cat and she was devastated. He was missing for 2 months and then suddenly showed up under her porch. Then he was ill and died 2 weeks later. Such an unhappy ending, but at least she had him back for a while. It's still a mystery where he'd been all that time.

Mr. and Mrs. Mike Steines and their daughter looked in on our March meeting. They are in the market for a puppy and found the information about our

meetings on our web site. So nice to know people actually do find us that way. They were very nice, here's hoping they find what they're looking for. Maybe they'll be back at a future meeting with their new puppy!

They have closed down Carco Park where we hold our specialty shows, so keep your fingers crossed that it will be opened up again in time for our shows. Keep watching the newsletter or any emails you receive from Lorrie about that subject.

Betty Winthers received some boxes from Rose Roberts filled with GSD items that Ralph had collected over the years. 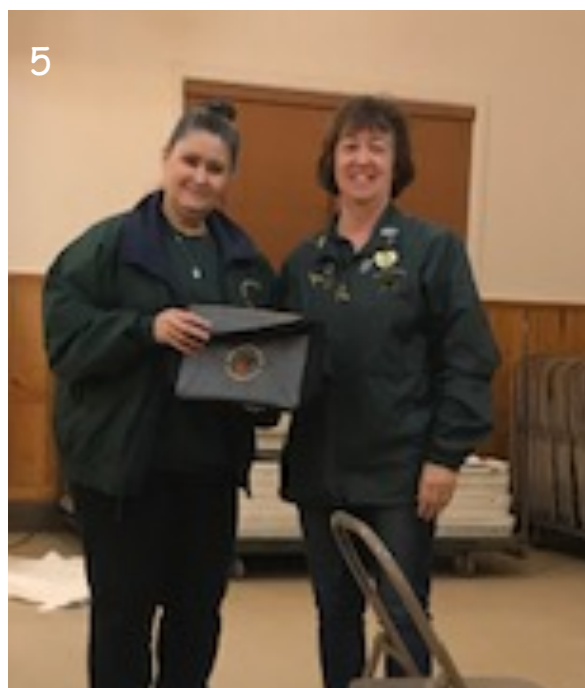

### In Memory of Club Member Mary Fisher

Mary and her identical twin sister, Elizabeth Hains, first acquired their love of the German Shepherd from their mother, who imported a Shepherd from Germany, Klodo, before they were born.

When they moved to Washington in 1972, they immediately joined the GSDC of Washington. Mary purchased Von Nassau's Heidi, a Trago daughter; and Elizabeth purchased San Lo Ann's Sy, by Ch Dot-Wall's Vance, CD, ROM, x Ch San Lo Ann's Bonnie.

Betty Winthers entrusted them with making 1000 front & back 8" x 10" numbers for the 1973 GSDCA National in Washington in 1973, which were used for many, many years by the handlers in the rings (instead of arm bands) until totally worn out.

Elizabeth continued breeding multiple champions, as Ariana Shepherds, and later Ariana Manchester Terriers. Mary later bred top winners as Mariza Borzoi and Mariza Italian Greyhounds.

Pictured here, Mary was judging a Specialty Sweepstakes for the GSDC of WA, as always very intent on a careful observation of movement. She always said that if a person wanted to learn dog movement they should sit at the ringside of the German Shepherd Dogs.

She loved her GSDCWA friends and always enjoyed sharing stories at the shows.

## CANINE LEGISLATION REPORT

Well here we are at the end of the short legislative session. Of the bills purposed this year, only two are hitting the Governor's desk for signing, and there should be no issue with him signing them off to become law. Also we have a lot of changes in the rules and laws for flying with your service animals, we will start there.

After this article we will post the AKC information on the new D.O.T. flying rules, BUT basically D.O.T. has given the airlines free rein at this time to make their own rules, which will be going into effect shortly. (Federal D.O.T. will be monitoring these changes to make sure they are fair practices). Basically they are limiting service and support animals to dogs. No other animal will be approved, just dogs! The only support dogs allowed will be people with documented (by a mental health care professional) psychiatric issues requiring the physical assistance of a support dog, the fact that they provide physical assistance makes them a service dog. Airlines and D.O.T. are also defining the difference between a service dog and an emotional support dog - this is a big step in the right direction for all businesses and limiting the animals getting free access. Of course, you will be required to provide documentation prior to flying, so make sure to check with your airlines for their specific rules after March of 2020.

Here is the first of the two bills that should be signed into laws...

Amendments to the laws concerning the harming or killing a police dog, accelerant or detection dog, or a police horse. A couple little changes, (1)- the law presently reads if a person maliciously injures, disables.... Wording changed to intentionally... (2)- harsher penalties changing the category from a class "C" felony upgraded to a class "B" felony. I can't see how anyone could find fault on upgrading the penalties for intentionally doing harm to our animal enforcement animals, and evidently neither did our government.

The second law to go through was SB6300 and its companion bill, HB 2317, related to animal welfare.. This bill started last year and has undergone massive changes and rewrites. A pretty short substituted bill is what finally made it through both houses.

I think the biggest change that would affect responsible dog owners is when it comes to cropping ears and docking tails. It will be illegal for anyone other than a licensed veterinarian to perform these acts. It is also illegal to devocalize a dog if you're not a licensed veterinarian. There are a few other stipulations, as to how much of an ear or tail can be taken off, and the age of animals this is performed on.

Wording has been changed concerning animal sexual abuse, old law worded "sexual conduct", now it is "sexual contact". Just this small wording change is BIG and covers a lot more ground concerning animal sexual misconduct.

The new amendments also changes every section that concerns the conviction of any person committing animal cruelty. Old law reads that "a person convicted of animal cruelty shall be prohibited from owning, caring for, possessing, or residing with any similar animals..." Now the law reads any animals! I'm sure we all agree that this is also a good change! This change is in several areas of the animal cruelty laws. Also, convicted persons might find higher financial penalties and depending on the actual crime, a first- or second-degree charge.

A few changes concerning animals exposed to excessive heat and/or cold. Now, animal cruelty in the first degree, BUT not guilty "if the exposure is due to unforeseen or unpreventable accident or event caused exclusively by an extraordinary force of nature".

The other changes mostly cover animal abandonment, and how the authorities are to handle abandoned animals, and how to handle dangerous dogs. Also persons found guilty of abandonment will not be allowed to possess any animal for a two-year period on the first offense and more for second offenses. There is more to

this concerning appeals, financial penalties, reimbursement of costs incurred by animal control and/or holding facilities. If you wish more information on this, look up and/or google ESSB6300 Wash State bills. I would hope that any of you reading this article will not be affected by any of these changes!

All these little changes will take effect 90 days after our Governor signs the bill ( and it is expected that he will).

That is it for this year's legislative session. I will expect more bills on animals next year when we have a longer session and folks have a chance of getting new bills though. Expect to see the bill concerning the sales of pets at pet stores return, and I will be keeping an eye open for the return of this bill and be looking to see what changes are in the rewrite. This bill will concern all of us that breed and sell dogs!

Have a great summer, and remember to check the new flying regulations if you travel with your dogs!



The Federal government and the airlines have made a bill addressing all the animals in the air these days! NLY service dogs meeting a list of requirements will be allowed to fly for free in the near future! NO emotional support dogs will be allowed free flight. Thankfully the bill is very well written and very clearly defines the difference between service dogs and emotional support animals! SO, if you plan to do any flying with your animal, you need to check way ahead with your airlines to make sure you have all your paperwork in order and meet all the new requirement's for flying your service dog and/or animal!

# AKC Obedience

**News for our Obedience Judges & Clubs**

The Obedience and Rally Departments are adjusting the assignment limitations for judges, effective for trials scheduled through April 30, 2020. As more judges are restricted in their travel, we hope that this change will be helpful. If a club needs to replace a judge, AKC will waive the 30-day and 100-mile rule to the judge's assignment limitations. Clubs must still submit their request to change the judge and receive AKC approval.

Judge changes during this time period will be considered as an emergency basis as stated in the

Obedience Regulations and Judges Guidelines and the AKC Rally Regulations and Judges Guidelines. We will review any future need for this change at the end of April.

## My Journeys With Jax

Just a few short years ago you might remember reading a column by my Jax on some of the adventures we went on and upcoming club events. After being diagnosed with kidney disease our life took a drastic change. His column was no more.

After he passed away on February 15th I started going through hundreds of pictures of our journey the past nine years and decided to write one last column. This would be about my journey with Jax.

We entered obedience and herding trials, worked the club's educational booth, did duck herding demonstrations with Ewetopia but the most important thing was getting his therapy dog certification. Jax had big paws to fill after the sudden death of my Fritz.

Our places to visit were at Madigan Army Medical Center, Warrior Transition Battalion and the VA nursing home in Lakewood. We visited with patients in waiting rooms, receiving chemo, ICU, pediatrics and with the staff. There were a couple of housekeepers that were terrified of dogs but after some pets with Jax they became friends.

We had a visit with a Wounded Warrior that just stared at Jax for the longest time. After a while he finally pet Jax and said he had a GSD that looked like Jax. He showed me a picture of his GSD and said he was a K9 handler. His K9 unfortunately was killed in action after being blown up by a bomb. We spent a lot of time with that soldier and our visit really helped him. It was definitely one of the toughest visits we did.

We always visited the mental health floor. Jax went into the room where the patients met for group therapy. Jax went in first to walk up to the patients that were calling his name and happy to see him. I didn't know there was a patient in the corner of the room reading a pretty heavy book. All of a sudden the patient threw the book very hard at Jax hitting him in the side of his head and SCREAMING at the top of his

lungs. The counselor had to cover the patient immediately to try and calm him down. The other patients that knew Jax were really upset that the patient had tried to hurt Jax. Jax took it all in stride and just looked at the patient that was now calming down like "Dude, you just threw a book at me, really?" I immediately removed Jax until everyone calmed down. We eventually went back into the room so the patients could pet him. Before we left the scared patient asked if, he too, could pet Jax. He apologized for what he did and said he was attacked by a dog when he was a child. It was a great moment having him pet Jax to get over his fear of dogs. He did it with the encouragement of the patients too.

On a different floor there was a sweet and confused senior lady on the ward. The nursing staff were switching her to a private room. She kept yelling at the top of her voice, "Help me, help me, they're trying to steal me". She kept yelling this over and over for a good 45 minutes. I asked one nurse if we could be of assistance? I was told with a firm NO, we have it under control.

Ok, so off we went to do our other visits on the floor. The other patients were getting upset with all of her screaming. As we came around by her new room I poked my head around the door way to see a room full of nurses and one trying to get the lady out of the wheel chair into her bed. She was fighting tooth and nail to not do it. Well, Jax also poked his head around the corner and the lady saw him. She immediately stopped screaming and looked at me and said "What a gorgeous dog bring him in here". So in we went. The lady asked if she could pet Jax. I said of course but before you do I need you to do one thing. I said, "I need you to get out of the wheel chair and get into your bed." Which she did immediately. She grabbed my arm to whisper in my ear that these people were trying to kidnap her. I said no these people are the nursing staff. You're in the hospital and they're just trying to get you comfortable and help you get settled and that she was safe and no one was trying to kidnap or hurt her. When I looked at all the nurses in the room I saw a lot of shocked faces. With that she got to pet Jax. I heard one nurse mumble as they all walked out of the room..."All we had to do was get the therapy dog to help'.


When we would visit patients receiving chemo, they did it in a large room. The patients never talked to one another. But when Jax showed up they would look at him and smile. Many asked me questions about him. Then the patients started talking about their dogs. After our visit the conversations continued.

The VA nursing home was another great place to visit. What an honor to be able to chat with some of our honored veterans. A lot of them had pictures of them

during WWII, Korea and Vietnam. The biggest treat was waiting for the gal that walked around with us. The guys and a couple of ladies would sit at a huge table and drink their coffees. That was the perfect place to start old war stories. One Veteran said his plane was shot down over Italy. The plane crashed and he and his pals had to find places to hide from the enemy. All I could think of was, history, right here before me.

My time with my Jax will be one I shall cherish forever. I'm so happy I had another awesome dog to share with so many people. Jax logged thousands of visits over the 5 years of our weekly visits. Now he visits with some of the wonderful patients that became friends over the years.

We hear this every now and then, in different ways. It's not the adventure at the end of the trip, it's the journey we take to get there. It is so true.
