Later in the day I drove back to the lookout on I-5 and heard several people talking about hearing it all the way up in Seattle. And we heard nothing...the dogs weren't making THAT much noise. Luckily, there wasn't that much fallout at our place, but just to be sure we brought them into the house and garage for a few nights.

April Stanke posted a cute picture of an ashtray she made out of (what else?) ash from the mountain. It was pretty cute...and being a kind person she even put a cave in the side of it for Harry Truman to hide in. Unfortunately, that part wasn't true. For years after that event clever people made all kinds of items out of that ash. I think I even bought a pair of earrings at a craft sale made from it.

The Wenatchee/Moses Lake shows in central Washington held their annual shows that year, or the following year, and there were piles of ash bulldozed along roads in Moses Lake. There was a big wind storm the first day. I was judging obedience and we had to put the bar jump up just before that exercise with each dog as the wind kept blowing it over. My hair that night was so stiff from dust it was terrible. They even closed I-5 that afternoon.

When some of us predicted this, we were just joking! Now AKC has changed the way new people to Rally can earn their legs in Rally Novice now that many shows have been cancelled: They are putting out 5 rally patterns, you choose which one you want to work, have you and your dog videoed working that pattern, send it to AKC who has rally judge(s) look at it and score you. If you'd like more information on this great new invention of theirs, check it out on AKC.org or check out page 11 if you don't believe me...

When there wasn't anything interesting on tv one night, I watched two episodes of "Spy in the Wild" on channel 9. They have all these "spy" animals they make with cameras in them so they can get close to wild animals and film them (one of its eyes is a camera). Some of them look pretty real and certainly don't bother the real animals. They must have had at least 10 different animal "spies" — elephants, tigers, beaver, alligators, bats., you name it. Pretty neat. The next time you are in the wilds, that animal that doesn't look quite right to your uncultured eye may just be one of the "spies". They make them that can fly, swim, you name it.

So here's your accidental/unconscious training tip for the month. Whenever you do something basically the same each time, your animals will pick up on it. Dogs learn easily from repetition. Sometimes this is good and sometimes it is not so good. One example many people can relate to is the dog who rushes to greet them when they come home, jumping and barking, making it difficult to even get all the way in the house. But you probably unknowingly trained the dog to do this. When they are puppies (or for a new dog) and you come home, you make a big deal out of it, getting them all excited. So if you don't want to start this hysterical greeting, just walk calmly into the house, basically ignoring the dog for about 5 minutes. You can say "hi" calmly (but no touching) and then go about the business of taking off your coat, putting packages away, etc. When you have finished all that, greet the dog calmly, giving it a hug or letting it jump in your lap (for small dogs). Save the hysterical-type activities for when you are ready for them and have the time to hype your dog up and play with it, if only for a few minutes. On young dogs it doesn't take long to discourage the mad door greeting, for a dog that already has the habit it will take longer, but if you are consistent about a calm entry your dog will eventually calm down.

After training classes for several years, I bought a miniature poodle (Barbie) to show people I could work with small dogs as well as large dogs. Over the years I can't count the number of times students would come up to me after class to tell me they really didn't like poodles, but they thought Barbie was really great. When I asked why they didn't like poodles, they inevitably said because most were so yappy. After hearing this over and over, I realized she wasn't yappy because I had never encouraged her to bark. Some people think it is so cute when a young puppy barks and they encourage them to do so. We played with fetching toys and balls, things that didn't make her bark wildly. I know that was the reason since my second poodle received the same compliments. I acquired him when Barbie passed away; Gunner was already

almost 3 years old when I acquired him. When he was handed over to me, the owner told me to never take him off leash or he'd take off and I would never catch him. Other people who saw him when he first came to live with me said I'd never be able to show him in the ring because he was so shy. After a few weeks, I took him with me and my daughter to a 4day trip to Canada when I was judging there. He was with us 24 hours a day - at the show, in the car, and in the hotel room. When I was judging, Melanie would take him for walks around the grounds or have him sit by her when she was watching the show. At the hotels we took him out to go potty so there were no accidents. After that trip he changed completely. Melanie (who was 11 then) trained him and showed him in Novice Obedience. He never ran off when the leash was taken off and he became a loving pet that lived to be 15. Yes, I also received the same compliments on him at class just as I had with Barbie.

Check out pages 7 and 8 about Erika and Luna winning top honors in the Front & Finish national Rally Novice ratings for the 2019 competition year. The second-place Australian Shepherd. was 68 points behind them, so it wasn't even close. Great showing for our great breed and for Erika showing her first dog

Also, the 4 Futurity plaques she donated to our specialty shows. I wanted to clear with her about leaving the original engraved plate on it and putting a card or plate on the back with the plagues' history and the name of the donor. Congratulations again you two, and good luck in your future dog show endeavors.



Congratulations to All Teams Placing in the 2019 Rally Novice Ratings!



Front & Finish® Rally Novice Ratings

The Front & Finish® Rally Novice Ratings rank dogs in AKC Rally Obedience competition who place first through fourth in any Rally Novice A & B classes during a given calendar year. One point is earned for each dog defeated within a class. For example, in a class of 20 competing dogs, the first place winner would receive 19 points as it defeated this number of other dogs. The second place winner would receive 18 points; third place, 17 points; and fourth place, 16 points. After points in each class are determined they are compiled across a given competition year and published in reports listing the top ten dogs across all breeds, the top ten dogs within each group, and the top ten dogs within each breed. All dogs tying for a given position are listed.

The Washington State Legislature has adjourned for the year, as originally scheduled.

Before adjournment, a significantly amended version of Senate Bill 6300 was passed. This bill's original version contained language that attempted to define animal pain to establish grounds for criminal charges for animal abuse and neglect. However, this terminology was broad and open to multiple interpretations making it difficult to enforce. In addition, AKC GR saw that the language could have also been used to subject responsible dog owners to unreasonable intrusions and accusations of abuse and neglect, even when engaging in normal,

accepted, everyday humane and safe activities with dogs.

The bill as introduced also sought to dictate the type of anesthesia that should be used by veterinarians when performing ear cropping, tail docking, and dewclaw removal - which could have proven very dangerous to young puppies.

The AKC would never condone harming animals, but this language, along with the vague definition of pain, were so broad they could also have prevented safe and accepted veterinary procedures and caused a range of unintended consequences.

After a committee hearing and numerous discussions, SB 6300 was amended to include even more problematic language defining animal pain by equating it to human pain. Proponents argued that having such a definition in Washington code would make it easier to prosecute cases of animal abuse and neglect.

AKC provided numerous research and scientific studies to demonstrate why the proposal could be harmful to dogs and responsible dog owners in the state. Equating human and animal pain may seem like a convenient way to explain it. However, the veterinary medical consensus is that it is impossible to do so, because there are so many differences, variables and competing factors in the comparison. In lay language, comparing animal and human pain is like comparing apples to oranges, and it is not in the best interest of dogs. The issue of defining pain in animals is tremendously complex and any attempts to define it should only be done after extensive consultation with leading expert veterinary resources and organizations.

AKC Government Relations contacted veterinary pain management experts, worked with legislators, and was a leader in a broad coalition of concerned state and national groups to have the bill amended. These amendments included removal of the troubling pain definition and the addition of other

clarifying language. In addition to the American Kennel Club, the coalition included sportsmen, agriculture, cattle and dairy organizations.

AKC was pleased to get the bill amended to remove the vague definition and add other clarifying language to ensure the best interest of dogs. The bill also now clarifies that ear cropping, tail docking, and dewclaw removal must be done by a veterinarian, using accepted veterinary protocols. The mandatory anesthesia provisions were removed.

Finally, AKC along with support from sportsmen groups succeeded in clarifying that when determining if an owner should be charged with cruelty for leaving a dog outside in "excessive heat or cold", the animal's breed, health, age, and physical characteristics (including whether the breed is physiologically adaptable to the conditions) must be taken into consideration.

Senate Bill 6300 as amended was passed by both chambers of the legislature and has been sent to the governor. AKC appreciates the legislature being willing to consider the AKC's concerns and make several amendments to the bill to protect dogs and responsible Washington dog owners.

We are also working on ways to engage our exhibitors across all sports via activities. In an effort to keep our beginner Rally competitors active and training their dogs, we have released the AKC Rally® Novice Virtual pilot program.

Rally Novice competitors can set up a pre-designed AKC Rally® course in the safety of their own yard, record the performance and submit it. In turn, AKC will assign a pre-selected AKC Rally Judge to virtually review and score the team's Rally performance. There will be five pre-designed official rally courses published on akc.org for the exhibitor to choose from. The exhibitor will follow the setup instructions provided, video the performance, upload the video to YouTube and submit the video link with the entry form and fee. The entry will be assigned to an AKC judge for scoring. All qualifying scores will be recorded on the dog's AKC record and applied toward the Rally Novice title requirements.

This is just one of the ways we are engaging exhibitors until we are able to hold events. We also

have many fun activities for dog owners of all ages, as well as COVID-19 updates on www.akc.org. It is updated daily. We are here for you. Staff is available to assist you during our regular business hours, Monday-Friday 8:15a-4:30p ET and customer service is available until 8p ET. I can be reached anytime on

my cell phone at 516-637-6567. AKC's commitment and loyalty to our sport, constituency and our treasured dogs is strong. We will continue to do everything possible to meet your needs and preserve

our sport. We can't wait to share an event with you! Stay healthy and be well. These are unprecedented times for the world and our sport. The AKC is aware

Support the Healthy Dog Importation Act NOW! - HR 6921

It's time - and **if you take action now** it's finally possible - to stop the flood of unhealthy dogs pouring into our country each year.

Thanks to the leadership of Congressman Ralph Abraham, veterinarian and medical doctor of Louisiana, and the co-sponsorship of the other two veterinarians in Congress, Kurt Schrader of Oregon and Ted Yoho of Florida, HR 6921, comprehensive, bipartisan legislation to protect the health of our pets, livestock and people was introduced on May 18, 2020.

Background:

The success of spay and neuter programs has eliminated the problem of dog overpopulation in many regions of the United States. The vast majority of US dogs are now spayed or neutered, and fewer dogs are born in the US each year. At the same time, demand for dogs has increased, outstripping US supply and leading to the import of dogs from all over the world.

According to a <u>2019 report</u> from the Centers for Disease Control (CDC) more than one million dogs are imported into the US each year. However, only about one percent of those are screened for <u>diseases</u> such as rabies, canine brucellosis, canine influenza, hepatitis, distemper, and others. This is a threat not only to other dogs and household pets but also to our livestock, the food supply, and public health.

The US dog Import system is broken. The dogs being imported come from countries that lack the veterinary, public health, and sanitation standards found in the US. Infectious pathogens exist in many of these countries that are not native to the US or were eliminated earlier. Many of these diseases can be transmitted to people and other animals.

The Healthy Dog Importation Act of 2020 (HR 6921)

The Healthy Dog Importation Act would require that every dog entering the country be in good health,

permanently identified, certified by an approved veterinarian in the country of origin to prevent fraudulent paperwork, and carry records showing that it has received all the proper vaccinations. Those entering the country for resale, transfer, or donation must be at least six months of age and accompanied by a USDA import permit. The bill would also streamline and coordinate federal oversight, ensuring documentation and import permits are shared electronically between APHIS, CDC, and Customs and Border Patrol, while clarifying APHIS' key enforcement authority.

These changes will go a long way toward ensuring that the federal government is responsibly screening the dogs entering our country each year, and discourage the spread of infectious diseases in thUS.

Act now - Urge your Congress member to support HR 6921, the Healthy Dog Importation Act of 2020


