This seminar will be broken into an AM session for Novice and a PM session for the more Advanced.

#### **Rally Seminar Schedule**

9:00 Intro to Rally: The AM session is open to any dog with basic home obedience, no prior Rally or Competition Obedience necessary. You will be introduced to the signs, how to read them, how to execute them with your dog and how to have fun!

12:30 Lunch Break

1:30 Advanced Rally Classes: The PM session will get more into how to negotiate the more difficult signs, address the new rules and how to move towards that perfect score. 5:15 Wrap up.

The balance in full is required at the time the reservation is made, or within 7 days of email reservations. Registration forms will be accepted up until the day of the seminar or until working dog spots are full. A waiting list will be kept once registration for working dogs and/or auditors is full. Working dog limit is 15 for each session. Auditors limit is 10.

#### **COVID POLICIES & PROCEDURES**

We ask that you complete a COVID Assessment Form prior to entering the facility. This will be e-mailed to you once you register. We recommend that you print this form at home, complete it, sign it and bring it with you when you come to the seminar. If you do not bring a form with you, we will have forms for you to fill out there. Please self-screen before you leave your home. Only healthy individuals may enter the facility. Anyone with a temperature of 100.4°F or higher is considered to have a fever and must stay home. Anyone with COVID symptoms, which include fever, cough, shortness of breath, fatigue, muscle aches or new loss of taste or smell must stay home and follow the isolation/quarantine requirements as established by the State Department of Health. Anyone who has a sick household member at home diagnosed with COVID-19, must stay home and follow the isolation/quarantine requirements as established by the State Department of Health. Masks are required. Please put your mask on before entering the facility. Please use hand sanitizer before exiting your vehicle. Please be self-contained by bringing your own chair & crate and maintain a 6 foot or more distance from participants not in your household. Lunch will NOT be provided. Please bring your own lunch, snacks and beverage. Please bring treats and water for your dog.
